## 3043 Welcome and apologies:

Cllr Matthew Phillips (MP) and Cllr Leigh Rawlings (LR) sent their apologies.

<u>3044</u> <u>Declarations of pecuniary interests and/or requests for dispensations from Members regarding any item on this agenda:</u> There were none.

<u>**3045**</u> <u>**Approval of Minutes of last Council Meeting on 17<sup>th</sup> May 2021**</u>: The minutes were approved and signed into the record by KG.

#### **3046 Oxfordshire County Council Report**: (attached at Appendix 1)

#### (i) DRAINAGE ISSUES ON GILLOTTS LANE

DB said OCC officers were working to resolve drainage issues that had arisen subsequent to the improvements to Gillotts Lane, and he had been advised remedial works were scheduled for October.

The Council noted the patience of the homeowner affected.

# (ii) UNNAMED ROAD LINKING A4155 TO HARPSDEN WAY (SHEEPHOUSE LANE)

While the OCC had wavered on whether to stand by their agreement to share the costs of renovating the surface of the Lane (Minute 3035 refers), the Highways Department was now willing to reconsider the scheme on conditions discussed in Minute 3048 (i) below.

#### (iii) P20/S2808/DIS: THAMES FARM

As previously reported, Taylor Wimpey had submitted a revised drainage proposal to SODC. This involved pumping the surface water from the site along the A4155 to a discharge point near Sheephouse Lane. Thames Water had stated it was unable to support the proposals until a range of issues had been addressed. Taylor Wimpey had responded to the Thames Water points but this response had not yet been assessed by SODC. The OCC/SODC drainage/flood response was expected within the next few weeks.

## (iv) P20/S4884/A 2 X ILLUMINATED ENTRANCE SIGNS AT BREMONT ENTRANCE

The PC had been supported by several other objectors to this proposal and the signs would not be illuminated.

The Council resolved to approach Bremont informally about the light pollution from the bright lights in the carpark.

#### **3048** Community Matters

KG said that MP John Howell would be meeting the Council on 14<sup>th</sup> October. As Harpsden Hall was unavailable on that date Ian Wason had offered a room at Harpsden Court but would not attend the meeting which was exclusively for the Council.

KG invited the Council and residents to put forward questions they would like to ask their MP.

## <u>3048 (i)</u> To consider a response to OCC's withdrawal of their financial co-operation on repairs to Sheephouse Lane

As OCC had revisited their decision and were willing to do the necessary repairs on Sheephouse Lane up to a cost of £120,000 to be split 50/50 the Council voted to proceed with this plan, on the understanding that the HPC contribution would be capped at £60,000.

The Council noted the drainage issues caused by the repairs to Gillotts Lane and those caused by the ditch. Both these items were the responsibility of OCC and needed to be addressed with them. This would be even more urgent as more housing went up in Highland Park.

KG said it was important that the camber on the road should direct run-off to the field and asked DB if this could be done by OCC. DB said it could as verges came under the control of OCC.

KG expressed the Council's thanks to ML who had physically cleared out much of the rubbish in the ponds.

# 3048 (ii) To receive any outstanding information on the Neighbourhood Plan and/or the drainage problem at Thames Farm

KG and ML had attended the Planning Meeting and the NP Committee reached the conclusion that the only way Henley and Harpsden could provide social housing was by opting for the extension of Highlands Park. Cllr Stefan Gawrysiak had complained that building there would increase traffic on Greys Road and KG said that he was right, but the housing numbers followed from the Governments planning policy. Extending Highlands Park was seen as the 'least bad solution'. KG also thought that Ken Arlett had been a fair-minded chairman of the Committee. ML said that following the extension of Highlands Park that OCC should be forced to revise their categorisation of Sheephouse Lane.

CR drew attention to LR's report that SODC had decided that the Thames Farm plans would need a new planning application. DB said that Taylor Wimpey were arguing the point and the outcome would probably be decided in Court.

CR said that Thames Farm was still in the NP. KG said that although it was not in the NP it counted on the SODC Local Plan.
